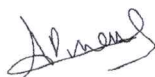

I.

1. By this Contract, the Guided Tour Provider agrees to provide guided tour services to the Customer under the conditions and terms hereunder, and the Customer undertakes to pay the agreed amount to the Guided Tour Provider for rendered services.

II.

2. Under this Contract, the Guided Tour Provider shall:

2.1. provide transportation to the Customer and accompany the Customer in accordance with the itinerary established by the Guided Tour Provider and ordered by the Customer;

2.2. provide the Customer with commentary on cultural, historical and natural heritage;

2.3. provide the Customer with basic information during the tour, including any practical information relating to the tour; and

2.4. provide the Customer with basic assistance during the tour.

3. The Guided Tour Provider undertakes to provide the Customer with services as specified in article 2 of this Contract on the following tour route:

4. The Guided Tour Provider is obliged to provide services as specified in Article II., Section 2. of this Contract to the agreed extent. If certain part of the tour itinerary cannot be observed by the Guided Tour Provider due to the given objective reasons, the Guided Tour Provider is entitled to change the itinerary in order to provide the Customer with the itinerary resembling as much as possible the one ordered by the Customer.
5. In performing the services as specified in article 2 of this Contract, the Guided Tour Provider shall use a licensed guide, i.e. an authorized person handling the provided services.
